**RESOLUTION NO. 8THCC-007**

**REQUESTING CITY MAYOR JOSEPH SALVADOR TAN TO GRANT FINANCIAL  
ASSISTANCE FOR DIALYSIS TREATMENT OF SANTIAGUEÑOS  
WITH END-STAGE RENAL DISEASE (ESRD)**

**WHEREAS**, Article II, Section 15 of the 1987 Philippine Constitution states that *“The State shall protect and promote the right of the people and instill health consciousness among them”*;

**WHEREAS**, Section 16 of the Local Government Code of 1991 provide that *“every local government unit shall exercise the powers expressly granted, x x x which are essential to the promotion of the general welfare”*;

**WHEREAS**, Section 16 of R.A. 7160 further states that *“within their respective territorial jurisdiction, local government units shall ensure and support, among other things, x x x promote health and safety x x x of their inhabitants”*;

**WHEREAS**, in the City of Santiago, there are more or less Seventy (70) Santiagueños with End-Stage Renal Disease with a yearly mortality of 20-30 patients;

**WHEREAS**, End-Stage Renal Disease (ESRD) occurs when the kidneys are no longer functioning and there is a need for hemodialysis treatment;

**WHEREAS**, Resolution No. 7<sup>th</sup>CC-77, *“Requesting City Mayor Amelita S. Navarro to Enter Into A Memorandum of Agreement with Hospitals In Santiago City with Facilities for Hemodialysis Treatment for Santiagueños with End-Stage Renal Disease”* was adopted by the Sanggunian to enter into a Memorandum of Agreement with hospitals in Santiago City with facilities for hemodialysis treatment for Santiagueños with End-Stage Renal Disease (ESRD);

**WHEREAS**, this resolution is needed for financial assistance of renal kidney patient who are having difficulty sustaining the costly treatment.


**WHEREFORE**, on motion of Coun. Arlene Jane Alvarez-Reyes, unanimously seconded, be it-

**RESOLVED**, as it is hereby resolved, to request City Mayor Joseph Salvador Tan to grant financial assistance for dialysis treatment of Santiagueños with End-Stage Renal Disease.
