RESOLUTION NO. 8THCC-037

AUTHORIZING THE CITY MAYOR, HONORABLE JOSEPH SALVADOR TAN, AS ONE OF THE SIGNATORIES ON BEHALF OF THE CITY GOVERNMENT OF SANTIAGO, IN LIEU OF FORMER CITY MAYOR AMELITA S. NAVARRO, IN ITS TIME DEPOSIT ACCOUNT NO. 1361-1285-12 WITH THE LANDBANK OF THE PHILIPPINES, SANTIAGO CITY BRANCH

 **WHEREAS**, the City Government of Santiago has opened and maintained a time deposit account with the Land Bank of the Philippines (LBP) Santiago City Branch with Account No. 1361-1285-12 designating the Hon. Amelita S. Navarro, City Mayor, and Ms. Elizabeth A. Casabar, City Treasurer, as its official signatories in all of its transactions with the said bank;

WHEREAS, while Hon. Amelita S. Navarro finished her term as City Mayor on June 30, 2013, Hon. Joseph S. Tan commenced his term as the new duly-elected City Mayor of Santiago as of such date;

WHEREAS, there is now a need to change one of the signatories of the City Government of Santiago in its aforesaid time deposit account with the LBP, Santiago City Branch, by replacing the name of the then City Mayor Amelita S. Navarro with the present City Mayor Hon. Joseph S. Tan;

WHEREAS, Section 8(b)(1)(f) of Republic Act No. 7720, otherwise known as the Charter of the City of Santiago, empowers the City Mayor, upon authority of the Sangguniang Panlungsod, or pursuant to existing laws or ordinances, to represent the city in all its business transactions and sign on its behalf all bonds, contracts and obligations and such other documents.


WHEREFORE, on motion of Coun. Arlene Jane Alvarez-Reyes, duly seconded, be it -

RESOLVED, as it is hereby resolved, to authorize the City Mayor, Hon. Joseph Salvador Tan, as one of the signatories on behalf of the City Government of Santiago in lieu of former City Mayor Amelita S. Navarro, in its Time Deposit Account No. 1361-1285-12 with the Landbank of the Philippines, Santiago City Branch, the other one being Ms. Elizabeth A. Casabar, City Treasurer;


RESOLVED FURTHER, to furnish copies of this resolution to the Land Bank of the Philippines, Santiago City Branch, and to all other persons and offices concerned for their information and guidance.
