RESOLUTION NO. 8THCC-041

AUTHORIZING THE CITY MAYOR, HON. JOSEPH SALVADOR TAN, TO ENTER INTO AND SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF SANTIAGO, A MEMORANDUM OF AGREEMENT WITH THE NATIONAL HOUSING AUTHORITY (NHA) RELATIVE TO THE LAND DEVELOPMENT OF THE CORE SHELTER/RESETTLEMENT SITE AT BARANGAY BANNAWAG NORTE, CITY OF SANTIAGO

 **WHEREAS**, the provision of decent and affordable shelter for the homeless and underprivileged is one of the priority development thrusts of the City Government of Santiago as mandated by the pertinent provisions of the Local Government Code and the Urban Development and Housing Act (RA 7279);

WHEREAS, the Local Government Code allows national agencies to complement nationally-funded requests, facilities, programs and services jointly or with the assistance of the local government units;

WHEREAS, the National Housing Authority (NHA) is equally desirous to extend the necessary assistance to the land development of the core shelter/resettlement site to be identified by the City Government of Santiago;

WHEREAS, the City Government of Santiago has specified certain parcels of land owned by and registered in its name, located at Barangay Bannawag Norte, this City, as conducive to the proposed core shelter/resettlement site project to be collaboratively implemented by the NHA and the City Government of Santiago;

WHEREAS, such collaborative undertaking requires this Sanggunian to authorize the Honorable City Mayor Joseph Salvador Tan to enter into a Memorandum of Agreement, for and in behalf of the City Government of Santiago, with the above-stated national agency;

WHEREAS, Section 8(b)(1)(f) of Republic Act No. 7720, otherwise known as the Charter of the City of Santiago, empowers the City Mayor, upon authority of the SangguniangPanlungsod or pursuant to existing laws or ordinances, to represent the City in all its business transactions and sign on its behalf all bonds, contracts and obligations and such other documents;

WHEREFORE, on motion of Coun. Arlene Jane Alvarez-Reyes, duly seconded, be it -


RESOLVED, as it is hereby resolved, to authorize the City Mayor, Hon. Joseph Salvador Tan, to enter into and sign, for and in behalf of the City Government of Santiago, a Memorandum of Agreement with the National Housing Authority (NHA), relative to the land development of the core shelter/resettlement site at Barangay BannawagNorte, City of Santiago,

upon such terms and conditions which the City Mayor may deem necessary, proper, legal and beneficial to the City Government of Santiago.

RESOLVED FURTHER, to furnish a copy of this resolution to all persons and offices concerned for their information and appropriate action.
