WHEREAS, the 2014 Local Development and Investment Plan (LDIP) and the Shortlist of Priority Projects to be funded out of the 20% Economic Development Fund (EDF) for CY 2014 of the City Government of Santiago have been presented, deliberated upon by the City Local Development Council (LDC) during its October 09, 2013 meeting held at the Sangguniang Panlungsod Session Hall, Santiago City, was approved and adopted by virtue of CDC Resolution No. 2013-01;

WHEREAS, these proposed projects and programs contained in the approved Local Development and Investment Plan (LDIP) has a total amount of P9,651,396,600.00 Billion, a large amount which cannot be accommodated by the budget ceiling under the 20% Economic Development Fund (EDF) of the proposed 2014 Annual Budget of the City Government of Santiago;

WHEREAS, out of these proposed projects under the Local Development and Investment Plan (LDIP) of CY 2014, there is a need to submit the Shortlist of Priority Projects to be funded under the 20% Economic Development Fund (EDF) amounting to One Billion One Hundred Eighty Million Pesos (P1,180,000,000.00) of the proposed Annual Budget of the City Government of Santiago for CY 2014 to the Sangguniang Panlungsod for its evaluation, review and approval.

WHEREFORE, on motion of Coun. Arlene Jane Alvarez-Reyes, unanimously seconded, be it –

RESOLVED, as it is hereby resolved to approve the 2014 Local Development and Investment Plan (LDIP) and the Shortlist of Priority Projects to be funded under the 20%

Economic Development Fund (EDF) amounting to One Billion One Hundred Eighty Million Pesos (P1,180,000,000.00) of the proposed 2014 Annual Budget of the City Government of Santiago.


