RESOLUTION NO. 8THCC-069

REQUESTING THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) MAIN OFFICE, MANILA, THROUGH SECRETARY RAMON J. P. PAJE, TO DONATE CONFISCATED LOGS/LUMBER TO BE USED FOR ADDITIONAL CLASSROOM CHAIRS OF DIVISORIA HIGH SCHOOL-NAGGASICAN EXTENSION, NAGGASICAN, SANTIAGO CITY

 **WHEREAS**, Divisoria High School-Naggasican Extension is now on its 2nd year of operation as an extension school, giving quality education to the remote areas of eastern part of Santiago City;

WHEREAS, the current number of classroom chairs of the said school is equivalent to the student population for school year 2013-2014, which is 108 students;

WHEREAS, the recent pre-enrolment registration conducted by the said school shows the student population will be doubled for school year 2014-2015;

 **WHEREAS**, the said anticipated increase will eventually result in insufficiency of chairs and will negatively affect the students' classroom learning experience and the quality of education the said school provides;

WHEREAS, the promotion of quality education is among the top priorities of both the national government and the City Government of Santiago;

WHEREAS, the Barangay Council of Naggasican and the Divisoria High School-Naggasican Extension have asked the Sangguniang Panlungsod to support their resolution requesting the Department of Environment and Natural Resources (DENR) to donate confiscated logs/lumber to be used for the said school's classroom chairs;

WHEREAS, one of the sources of timber supply is the confiscated logs/lumber by the DENR which are presently under its custody and not subject of any pending litigation.

NOW THEREFORE, on motion of Coun. Brenda Ragsac-Luna, duly seconded, be it -

RESOLVED, as it is hereby resolved to request the Department of Environment and Natural Resources (DENR) Main Office, Manila, through the Honorable Secretary Ramon J. P. Paje, to donate confiscated logs/lumber to be used for additional classroom chairs of Divisoria High School-Naggasican Extension, Naggasican, Santiago City.


RESOLVED FURTHER, that the Sangguniang Panlungsod is supporting the resolution of Barangay Naggasican, Santiago City, entitled: "A Joint Resolution of the Faculty, PTA and the Barangay Council of Barangay Naggasican, Santiago City, Requesting the Hon. Joseph S. Tan,

City Mayor and the City Council of Santiago City, Isabela to Support Our Request for Lumber to the DENR for Armchairs for DHS-Naggasican Extension.”

RESOLVED FINALLY, that a copy of this resolution be furnished to the Honorable Secretary of the DENR, Ramon J.P. Paje and to all other concerned persons/entities for their information and appropriate action.
