RESOLUTION NO. 8THCC-075

AUTHORIZING THE CITY MAYOR, HON. JOSEPH SALVADOR TAN, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT FOR AND IN BEHALF OF THE CITY GOVERNMENT OF SANTIAGO WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FIELD OFFICE 02 CONCERNING THE IMPLEMENTATION OF SUPPLEMENTARY FEEDING PROGRAM FOR DAY CARE CHILDREN IN THE CITY OF SANTIAGO

WHEREAS, Republic Act No. 8980, otherwise known as the Early Childhood Care and Development (ECCD) Act, seeks to ensure, among others that adequate health and nutrition programs are accessible to young children throughout their early childhood years;

WHEREAS, the Department of Social Welfare and Development (DSWD) is among the government agencies that provide technical assistance and support for the National ECCD Program;

WHEREAS, one of the activities that the DSWD conducts as part of its contribution to ECCD Program is the Supplementary Feeding Program, which is the provision of food, in addition to the regular meals, to currently enrolled day care children;

WHEREAS, the DSWD Field Office 02 is ready and willing to implement the Supplementary Feeding Program in day care centers within the City of Santiago while the City Government of Santiago agrees that such program be implemented within its jurisdiction;

WHEREAS, Section 8(b)(1)(f) of Republic Act No. 7729, otherwise known as the Charter of the City of Santiago, empowers the City Mayor, upon authority of the Sangguniang Panlungsod or pursuant to existing laws or ordinances, to represent the City in all its business transactions and sign on its behalf all bonds, contracts and obligations and such other documents.


WHEREFORE, on motion of Coun. Arlene Jane Alvarez-Reyes, duly seconded, be it -

RESOLVED, as it is hereby resolved, to authorize the City Mayor, Hon. Joseph Salvador Tan, to enter into and sign a Memorandum of Agreement for and in behalf of the City Government of Santiago with the Department of Social Welfare and Development Field Office 02 concerning the implementation of Supplementary Feeding Program for the day care children in the City of Santiago.

RESOLVED FURTHER, to furnish a copy of this resolution to all persons and offices concerned for their information and guidance.
